We will constantly seek to provide the best value possible to the customer.

We will, to the best of our ability, devote all of our employees to the application and maintenance of honest and reliable roofing and siding work.

We will treat all our employees in a fair and ethical manner.

We will comply in spirit with all rules and regulations prescribed by law for the health and safety of the community and the environment. And, we will secure all the necessary insurances, including liability and Worker's Compensation.
